Office Order

Guideline: for Empanelment of Private Hospitals under Ayushman Bharat-Mahatma Gandhi Rajasthan Swasthaya Bima Yojana in the State of Rajasthan was issued vide no. 778 dated 02-07-2020. Following amendments are done in the existing guidelines w.i.e.-

| 2 | All doctors working in the hospital whether full time or part time should be registered under Rajasthan medical council. | All doctors working in the hospital whether full time or part time should be registered under Rajasthan Medical Council. In case he/she has applied for registration in RMC but certificate have not been issued, such hospital may be allowed for a period of 03 month if hospital declares to produce RMC certificate within due time. |
| | | In case doctor is registered in RMC but its certificate is expired, such doctors will be allowed to work for a period of 03 months. Hospital has to produce renewed certificate within stipulated time period. |
| | | DEC shall verify such application during visit and write a clear remark in DEC inspection report. |
| 3 | Hospital Should have inpatient beds as detailed below with adequate spacing and | Hospital Should have inpatient beds as detailed below with adequate spacing and supporting staff as per norms: |

It is also clarified here that-

| 1 | Hospital is working for more than two years but location of hospitals has been changed due to shifting of building. Since Rajasthan Pollution Control Board issues certificate for specific location, therefore such newly shifted hospital cannot provide certificate of Rajasthan Pollution Control Board as a proof for working for two years. | Hospital shall have to submit certificate as per amended provision as a proof for more than two years of working. Name and ownership of hospital should be the same. In the new set up, hospital must fulfill all other essential criteria too. |
| 2 | Hospital is working for more than two years but ownership of hospital or name of hospital have been changed. | Application of such hospital can be considered, provided the new hospital owner/(s) was not punished (Penalty/Deempanelment) for found to be indulged in any kind of fraudulent activity in the previous phase/current phase of the scheme. |
